Hosting in Norway

The Monthly hosting fee is invoiced starting at 0.059 €/kWh for a 1 year contract and €0.065 €/kWh for a 2 year contract.

Included in hosting fee:

- ✓ Use of facility and infrastructure
- ✓ Use of Hydro and wind power
- ✓ Use of Cooling, Shelves, network
- ✓ Daily operation of the datacentre
- ✓ Maintenance of all moving parts in the datacentre
- ✓ 24/7 onsite security
- ✓ Use of Direct air cooling
- ✓ Total power usage
- ✓ Use of PDUs, Switches and Cables

MOQ (Minimum Order Quantity)

- 1 miner consuming at least 2.5 kw

Contract Duration

- The Operating Agreement shall have a term of twelve months from the effective date of the agreement.

Additional Monthly service fees

Monthly miner check/rack space fee of €25,-/ ASIC including:

- Labor for spare parts (fan systems, instrument panels, psus, etc.)
- Maintenance
- Remote and on-site reboot
- Pool switching (can be done by yourself)
- Failure analysis and monitoring

One time service costs

- 2 months of deposit on the power consumption, reimbursed at end of the contract.
- Facility slot fee €350,- per miner
- Miner installation fee of €250 excl. VAT per miner, including
 - Unpacking of miners and power supply
 - Use of 1x PDU port, 1x Switch port, 1x power cable and 1x ethernet cable per miner
 - Packaging material disposal
 - Placing access network switches on shelves
 - Connect access switch uplink to distribution switch
 - Mounting rig in shelf
 - Connect power supply to rig (internal power cabling)
 - Connect rig to power (PDU) and network (access switch)
 - Power on
 - Adding the machine to the monitoring system and software;

INFRASTRUCTURE

Energy and Uptime

- 100% Green energy: 93% Hydropower and 7% wind power
- Average uptime of > 95 %
- Miners are hosted in a purpose-built facility using container-based infrastructure designed for ASIC operations. The containers support both air and water cooling, making it possible to adapt to different miner models and efficiency needs.

Monitoring and VPN

- Access to miners through a professional cloud software monitoring tool
- VPN network access can be provided for 50+ miners and is subject to a quotation.

SHIPPING AND VAT

SHIPPING POLICY

The shipment to Norway must be organized this way:

- **By Antminer Distribution Europe:** who buys the miners or moves his ASIC and takes care of shipping and administration of the declaration of value to customs (and is solely responsible for all applicable import duties and taxes). Goods will be shipped DDP (duties paid). However the customer will be charged a flat fee of €90,- up to 10 miners for customs clearance.

VAT

- **Details of our Norway Facility**
Cheaper electricity rate of €0.059/kWh, with no additional take-or-pay constraints.
More flexibility in scaling your operations as needed.
Favorable political climate, clear regulatory environment, and 0% import taxes.
No additional taxes on hosting, making it a cost-effective option.

WORKING PROCEDURES

- Power usage and monthly charges are invoiced in arrears. Invoices will be sent out in the first week of the month and are due 7 days later. For example, for usage in October, the invoice would be sent out on the 1st of November and would be due on the 8th of November at the latest.
- Customers are not allowed to turn off their miners during the contact duration. They have 90 working days notice period to end the contract or choose to not prolong the contract.
- Flexibility in payment options: Monthly hosting fees can be paid in EUR, Bitcoin, or other stablecoins such as USDC.
- Precision billing: The customer will be billed for the exact amount of electricity his miners consume while being hosted in our facility. This ensures that he is charged accurately based on his actual usage, rather than a flat rate or estimate, ensuring transparency into your energy consumption cost-effective operational expenses.
- Downtime caused by failure in the services of the hosting provider (power or network failure), the downtime will be credited by the hosting provider;
 - In case the machine is broken, the Customer can request to permanently remove the machine from the site to stop invoicing;
 - Credit notes for downtime are issued every 6 months.
- A helpdesk is available during office hours via email and telephone.
- The Asic miners shall be plugged in within 4 days after receiving both the miners on-site and the deposit has been paid.
